*NOTE: The IRS has released <u>Notice 2016-70</u> granting an automatic 30-day extension of the due date for furnishing to individuals the 2016 1095 statements from January 31, 2017 to March 2, 2017. Even though the IRS is granting the extension, they encourage employers and other coverage providers to furnish statements and file the information returns as soon as they are ready.



Based on the IRS extension, the cut-off for all submissions is 12 PM CT on Tuesday, February 28, 2017 to ensure the employee copies are printed and mailed timely. You may submit batches after 12 PM CT, on Tuesday, February 28 2017, but we are not able to guarantee the batches will be processed by the March 2, 2017 deadline. **Note:** An additional 50% charge for submissions made after 11:59 PM CT on February 21, 2017 will be waived for the 2016 filing year.

The IRS is not providing relief from the deadlines to transmit the 1095 forms to the IRS; those deadlines remain February 28, 2017 for paper filings and March 31, 2017 for electronic filing.

If you will be utilizing ftwilliam.com's fulfillment service to electronically file your 1094-B/1094-C and 1095-B/1095-C forms to the IRS, the following dates apply:

The cut-off for all submissions is 12pm CT on Tuesday, March 28, 2017, to ensure all forms are electronically filed with the IRS by the March 31, 2017 deadline. You may submit batches after 12pm CT on Tuesday, March 28, 2017, but we are not able to guarantee the batches will be processed by the March 31, 2017 deadline.

To avoid multiple batch charges, submit your batch for fulfillment by the February 28, 2017 deadline to have ftwilliam.com print/mail the Employee copies AND e-file the forms with the IRS all at the same time; you do not need to create two separate batches for these options.
