If you would like to use ftwilliam.com's fulfillment service to provide your Employee copies by the <u>NEW IRS deadline</u>, the following dates will apply for your batches:

The cut-off for all submissions is 12pm CT on Monday, March 28, 2016, to ensure the employee copies are printed and mailed timely. You may submit batches after 12pm CT on Monday, March 28, 2016, but we are not able to guarantee the batches will be processed by the March 31, 2016 deadline.

If you will be utilizing ftwilliam.com's fulfillment service to electronically file your 1094-B/1094-C and 1095-B/1095-C forms to the IRS, the following dates apply:

The cut-off for all submissions is 12pm CT on Monday, June 27, 2016, to ensure all forms are electronically filed with the IRS by the June 30, 2016 deadline. You may submit batches after 12pm CT on Monday, June 27, 2016, but we are not able to guarantee the batches will be processed by the June 30, 2016 deadline.

NOTE: You may submit your batch for fulfillment by the March 28, 2016 deadline to have ftwilliam.com print/mail the Employee copies and e-file the forms with the IRS all at the same time; you will not need to create two separate batches for these options.
